

"Parish Community Tithe" "Centennial Campaign"

In prior years, the diocese made an assessment of all of its parish churches on an annual basis under a program called the Annual Catholic Services Appeal

("ACSA"). This assessment provided for the needs of the Diocesan Church--items such as the bishop's office and the administrative and service departments of the diocese. Most of these services would be too unwieldy or inefficient to handle on our own without hiring a much larger parish staff: accounting & insurance services, administration of employee benefits such as healthcare, pension, unemployment, and worker's comp, services such as the Office for Divine Worship, the Mission Office, the Office for Education, Stewardship services, and the Catholic Times. The diocese also assumes the responsibility for the sizable expenses in seminarian education (priests and deacons) as well as ongoing clergy formation.

Rather than being assessed by diocese annually (which has unwittingly lead to us having annual shortfalls which become debt when we are unable to pay the assessment), we now pay "as we go" through the Parish Community Tithe (PCT) to the diocese. This is a tithe (10%) of all parish (non-school) income. Two advantages of the new system: you no longer receive a request to make a contribution to the annual appeal, and the assessment is 10% rather than approximately 12% in the past. Since we have made tremendous efforts in recent years to fix our financial systems and standing, it also has the advantage of helping discipline our spending a bit more to make sure that we have our PCT paid out 'before' any other

Dear Parishioners,

I am proud to present the Financial Report for the Fiscal Year ending on June 30, 2024. Besides being a requirement of diocesan and civil law, this report offers an important opportunity to discuss the temporal needs and workings of our parish. Our parish simply cannot fulfill the Great Commission of teaching and baptizing (cf Mt 28:19) without the resources of time and talent and treasure provided by its members and friends. For this, I offer a profound word of thanks.

This year we celebrate the 40th anniversary of the dedication of the "new" St. Anthony of Padua Church. We stand on the accomplishments and sacrifices of generations who have gone before us, and we now work to leave a legacy worthy of the future. We do this by investing in faith formation at St. Dominic School for our children and their families, and by investing in ministries, formation, and outreach for all who come through our doors at St. Anthony Church.

Over the last several years, we have been concentrating on keeping our budget tight, and have not invested in professional Stewardship development assistance, which has saved our parish tens of thousands of dollars. Unfortunately all of the glitzy, glossy publications and brochures which are part of a "Stewardship Campaign" are not in front of our people each year. This requires the parish, and me in particular as leadership, to make the directly effort to remind parishioners to review their stewardship giving to the parish each year to make sure that they are 'keeping up' with their commitments to the parish. I like it when we are able to keep fundraising expenses down by directly appealing to our parishioners' already-generous nature and thus making their contributions 'go farther'. Would you take this opportunity to recommit to tithing as a practice of parish stewardship? Yes, prices are up in recent years. There are those for whom additional sacrificial giving is not possible, but for those of us who have received raises and promotions, cost-of-living adjustments, and pay hikes in recent years, maybe this is the year to re-calibrate their stewardship giving, so that we can keep our parish and school strong in the midst of rising prices there, too! A chart of suggested tithing levels is on the back of this report.

Thanks to our parishioners and friends, we are meeting essential benchmarks that indicate financial stability for the parish and in the school. We are making progress on maintaining and enhancing our facilities, and offering a high-quality elementary school program. We continue to trust in God's graces to lead us into a bright, faith-filled future.

spending in the parish, helping us to avoid taking on any more debt! Our payments to the diocese have gone down approximately \$10,000 per year in this transition. We do ask you to consider your stewardship tithing to the parish in light of this change in our local needs and our collective support of the Diocesan Church.

Next year, we will be announcing our participation in the diocesan "Centennial Campaign" which Bishop Paprocki has asked parishes to undertake. This campaign takes place at the 100th anniversary of the translation of the diocese from Alton to Springfield. Part of the inspiration for this campaign comes from the needs of the diocese to maintain and do additional repairs to our Cathedral Church. Rather than simply assessing the parishes of the diocese for the funds required for this work (as has been done in the past,) Bishop Paprocki is asking our parishes to also consider the strategic needs of their own parishes and to run a dual campaign for both causes. The local focus of this campaign will thus be on our own needs and repairs and parish life, with a tithe (10%) for diocesan needs.

We are aware of a number of local needs which include structural repairs/maintenance to the east walls of St. Anthony Church, the removal of the steeple from the Church (and hopeful replacement with a structure that is more practical from an engineering perspective,) re-paving of the school parking lot, replacement of the school gym floor, updating our kitchens at church and school, and continuing the develop our Fr. Irenaeus Memorial Scholarship Fund, our cemetery income-care account, and our parish perpetual endow-

ment fund. Our leadership councils continue to research and prioritize these needs in anticipation of our campaign.

Along with the diocesan Church, we are being asked to make the most of this opportunity to examine our needs for the future. Our parish church and its school have been given to us as a gift, and in the spirit of good stewardship, we are making decisions and commitments which will secure that gift for those who come after us..
